Royalty rates for intellectual property are usually set as a percentage of revenue. For example, the royalty rate could be 6%, based on net sales and paid on a quarterly basis. This means that, each quarter, the licensee must pay the licensor 6% of the net sales generated by the intellectual property that quarter.
